DMA ACTION ITEMS AND UPDATES

2018 Event Update: Staff gave an update on the 2018 event season including the amount of sponsor dollars received to date.

P&L Cinco de Mayo and Festival Park Grand Opening: Staff presented profit and loss statements for the first two DMA events of the season. Both statements will be finalized in July when the remaining two expenses, sales tax and a music license fee, will be deducted.

Preliminary P&L Car Show Concert: Staff expanded the Car Show Concert event layout to accommodate the 1,500 attendees that came to Wilcox Square for a preview of the 10th Annual Classic Rock Cruise In Car Show. Fifty classic cars lined Wilcox while the dance band, Deja Blu, played from 6 - 9pm. Event attendees enjoyed brews from Rockyard, 105 West and Bristol Brewing Company. Staff presented a high-level preliminary profit and loss statement for the event.

Preliminary P&L Car Show: Downtown Castle Rock celebrated the 10th Annual Classic Rock Cruise In Car Show on Saturday June 16, 2018 with event co-producer, the Vintage Car Club. Over 300 classic and exotic cars were on display while kids enjoyed free activities. Estimated attendance is approximately 8,000 people. Staff presented a high-level preliminary profit and loss statement for the event.

Board Elections: Mike Trede and Dennis Dickey's four-year term on the DDA Board expires at the end of June 2018. Both are eligible to serve another term. Staff posted the announcement on the Alliance website on June 22, 2018 and was shared at this meeting. The Board will make a recommendation to Town Council in July to fill both vacancies.

DDA Board Selection Committee: A selection committee of 2 board members was formed to meet with potential candidates for the 2018 DDA Board Election and make a recommendation to the Board. Nick Hier motioned to appoint himself and Stu Butler to be on the selection committee to meet with the DDA Board candidates and make a recommendation to the board. Stu Butler seconded the motion; motion carried unanimously by the DDA.

Executive Session – Downtown Projects: The Board entered Executive Session to determine positions relative to matters that may be subject to negotiations, develop a strategy for negotiations and/or instruct negotiations pursuant to CRS 24-6-402(4)(b). Dennis Dickey motioned to hold an executive session pursuant to CRS 24-6-402(4)(b), Mike Trede seconded the motion; motion carried unanimously by the DDA Board.

Dennis Dickey motioned to adjourn the executive session, Mike Trede seconded the motion; motion carried unanimously by the DDA.
